The Death Record.

Wong Chin, died suddenly yesterday afternoon at the Chinese hospital pest house, is the second Chinaman from the Pantheon saloon. There was a meeting of the Kalihi League last evening which was well attended. On the motion of Mr. T. McCants Stewart, the following recommendations were adopted by the meeting:

First-That immediate steps be taken to get the Government to widen and macadamize King street. making the same sixty feet wide, with 10 foot sidewalks on each side.

Second-That the Government be requested to place hydrants within the district and that a fire engine or engines be stationed therein, one of which to be located at or near the pumping plant.

Third-That the Government be requested to make some provision for the removal of garbage and refuse from the district.

The committee also reported the following matters for the information of the league, namely:

First-That a committee has been appointed to ascertain the names of property-owners along the line of School street extension, and to secure cessions from the same of land necessary to cut through said street from Lilihastreet to Kamehameha IV road.

Second-That a committee has been appointed to confer with Mr. Wm. C. Achi for the purpose of endeavoring to have him immediately organize an improvement league in the Palama district.

Third-That a committee has been appointed to take immediate steps to divide the district into apanas, so as to appoint supervisors for the same.

Condemn the Shacks.

The following letter was forwarded to the Board of Health yesterday:

Honolulu, February 1. 1900. C. B. Wood, M. D., President of the Board of Health.

Dear Sir;-We, the undersigned residents and property holders on Emma street, and adjacent neighborhood, do petition the Board of Health to condemn, and cause to be removed, the shacks on the Ewa corner of Beretania and Emma streets, and the two (2) wooden two (2) story buildings situated on the corner of Emma street and Emma Place, occupied as a Chinese laundry and Chinese store.

The said buildings have a large and mixed class of roomers or indwellers, and are in a highly insanitary condition, and are a menace to the health of the community.

We further believe that there has been no odorless excavator used on the premises for nearly two (2) years. Our inspectors have reported as to their insanitary condition, and we cannot understand why the Board of Health has not taken action era this. We cannot see how the said buildings can be placed in a sanitary condition.

We think they should be condemned and burned; cesspool pumped out.

#### Anti-Plague Precautions.

In view of the existence of the bubonic plague in Honolulu and Asiatic ports the supervising surgeon general of the Marine Hospital Service of the United States has issued a circular letter to Collectors of the Port making them acquainted with the additional quarantine regulations adopted by the service. The new rules are very stringent with regard to the inspection, detention and fumigation of baggage and cargo of vessels arriving from a suspected or infected port.

For instance, passengers shall not be vaccinated at or en route from ports or places infected with plague, such vaccination being held to increase the liability of plague infection, and by inducing fever and swollen glands tends to confuse the diagnosis at the port of arrival. This operation must be performed at the port of arrival and just prior to release from quarantine.

Mammalian animals, such as dogs, cats, monkeys, mice, etc, shall not be shipped from a plague-infected or suspected port or place.

The new rules were put into effect at this port yesterday.
