TOPICS OF THE DAY.

To have an inspector of restaurants and poi shops would be a great benefit to our sanitary affairs. We trust that a special officer will be delegated to look after these inst tutions. The agents of the Board of Health have their hands more than full under existing conditions.

As Chief Justice Judd resigned his position in December last but has drawn his salary regularly up to the first of this month, it will be in order for our absent friend to donate \$1000 to the newly started hospital for incurables. Bishop and Mrs. Willis would undoubtedly have much pleasure in forwarding him a receipt for the amount, and Dr. Bowman would appreciate the assistance for his patients.

The Advertiser is correct this morning when it practically suggests that the Government should go slow in the matter of aiding and abetting Chinese Secret Societies. This Government is merely a locum tenens, at the most, and should be extremely cautious not to complicate the friendly relations existing between the Governments of China and the United States. The trade of the Orient is worth more than disguised sentiment.

The Advertiser takes a most laudable interest in the place of imprisonment of General Cronj-, and the other Boer leaders when they are captured. H. B. M.'s Consul will be, homeward voyage shortly before undoubtedly, most derelict in his duty should be not suggest to Lord Salisbury that the Advertiser be consulted before these gallant men be dealt with. If THE INDEPENDENT might suggest, they should be invited to Hawaii, on parole, by the sugar barons to be used as lunas on the plantations and future leaders in labor strikes.

Captain Towse, chief of the paid inspectors of the Board of Health, is himself an affable and courteous man, and he should compel some of his staff to follow his example when entering the houses of regutable American citizens, or make them best a hasty retreat from his muster roll. We are informed that certain complaints of extremely rude conduct on the part of one of his men are already before the President of the Board of Health, and therefore refrain from more direct individual comment for the present.

Sixty-five thousand dollars is a goodly prize, even in these depraved days, for murder; but if aceidents happen the Government will have to pay to pay the cost of sundry trials and executions and prob-

Played With Pussy.

Mr. Southerland, recently an inmate of the Barracks Camp, was arraigned in the District Court today on a charge of cruelty to a cat.

The defendant is evidently a sea lawyer and he used many words in explaining that he only "played" with Pussy, a habit he had had for thirty years. Mr. Doyle who had charge of the camp at the time stated that there was no "play" in the business at all; that he had ordered the man to leave the premises owing to the fact of his being drunk, and that in going out Southerland picked up a cat; belonging to the premiser, by its tail and after swinging the poor animal around threw it against a fence.

This testimony was substantiated by a Japanese who is in the employ of the Board of Health.

The learned Magistrate agreed with the skipper saying that the Court had always found that defendant could be relied upon to be brought before him at least once a week. The only time His Honor missed him was when he occupied a cell in "Fort Henry." The cet was not produced but Southerland was invited to pay \$10 or go to jail for 20 days, the Court saying that while defendant might have enjoyed his ring up 32. playing with Passy it was safe to say that she took a very different view of the "sport."
